ALL PARTICIPANTS WILL BE CONTACTED VIA EMAIL. Rain date is set for Sunday, Nov. 5<sup>th</sup>.

Please include photographs of your work, your \$25 vendor fee, and a SELF-ADDRESSED STAMPED ENVELOPE (SASE) with your application. If you have been previously approved, no need for SASE or photos. Please just send application and check.

- 4. All spaces are 10 x 10 and all vendors must supply their own tents, tables and chairs. All tables should be covered with attractive holiday table coverings.
- 5. Your cashed check indicates that your application has been accepted. Vendors will be contacted via email. Confirmation emails will be sent with space assignments and set-up instructions. Payment must be received two weeks prior to event.
- 6. If you find that you are unable to attend after the receipt of your confirmation email, please notify us immediately.
